CIVIL REPRESENTATIVE ENGAGEMENTS

- Counsel for a public utility company in a multimillion-dollar insurance coverage dispute stemming from a horizontal directional drilling and PVC pipeline installation under the Kiawah River, South Carolina. The matter involved concurrent disputes in federal court and arbitration between the owner, general contractor, and two insurance providers over whether primary coverage was available under the owner's "comprehensive all-risk" or the contractor's "builder's risk" insurance coverage.
- Represented a public transportation authority in connection with the surety's takeover of multiple contracts in accordance with performance bonds after contractor defaulted on several large-scale, public works projects in Boston, Massachusetts.
- Counsel for a general contractor in a state court action and mechanic's lien claim against the owner in connection with the construction of a natural gas compression facility in Wetzel County, West Virginia. The general contractor sought the unpaid contract balance, delay, impact, and inefficiency costs related to erosion and sediment control issues on the site and a time extension for the owner-caused delay. The dispute also involved similar claims by certain subcontractors.
- Prepared a design-build contract on behalf of an Ohio-based, international appliance manufacturer to renovate the owner's corporate property.
- Pro bono counsel for the plaintiff in a civil rights action under 42 U.S. Code § 1983 in federal court resulting in favorable settlement after extensive discovery, involving numerous depositions of senior Pennsylvania Department of Corrections leadership.

MILITARY REPRESENTATIVE ENGAGEMENTS

- Negotiated, drafted, and managed more than \$17.3 million in supply and services contracts on behalf of the U.S. Government in Syria and Iraq. This included preparing commercial language and statements of work to meet U.S. forces' requirements in a combat zone as well as supervising, coordinating, and evaluating multinational contractors and vendors to ensure timely contract compliance. To accomplish these tasks, Carl led a contracting team spread across Iraq, Syria, and Kuwait to understand and articulate clients' requirements, navigate budgetary constraints, and execute the contracts.
- Directly managed multiple planning groups to shape complex issues for military commanders, including leading a multinational effort to develop a strategy for the rehabilitation of ISIS-affiliated children in Syria.
- Served as the general counsel to a commanding officer responsible for more than 1,200 Marines. Advised on fiscal law matters, investigations, sexual harassment and assault allegations, employee relations, and international agreements involving countries in Europe and the Middle East.
- Prosecuted 28 felony and 32 misdemeanor cases, including attempted murder, rape, sexual assault, child exploitation, fraud, drug distribution, larceny, and conspiracy.
